7.0 Audit of Accounts :

The accounts of HRF shall be got audited by the duly appointed auditors and shall get the same passed at the Annual General Body meeting every year;

8.0 Bank Account :

- 8.1 The Society shall open a bank account in the name of HUMAN RIGHTS FOUNDATIONS (HRF) which shall be operated either jointly by the President Secretary, and the Treasurer or any other designated members for which proper resolutions shall have to be passed and forwarded to the Bank concerned from time to time; Committees at National, State, District and Taluk levels can open, maintain and operate separate bank accounts in their own respective places in the name of HRF as per the rules and regulations laid down by the society for bank operations and can audit the accounts and submit the reports to the concerned authorities as the need be and to the society for verification.
- 8.2 That in the absence of the above three persons, the financial documents including cheques etc. can be signed by any other group of members of the Executive Committee nominated for the same with the approval of the President and the Secretary;
- 8.3 That whenever there is a change in the already notified signatory/ies, proper resolution shall be got passed by the Executive Committee and forwarded to the bank concerned for their record from time to time;
- 8.4 That in all the cases there shall be a minimum of three signatories at all times, and that it shall also be necessary to get the approval of the President in all such resolutions or documents before they are passed on to the Bank or any other institution/s concerned.

9.0 Submission of list of Executive Committee members to the Registrar of Societies :

Under sec. 4 of the Societies Registration Act 1860 or any other relevant Act, a list of the Office bearers including the members shall be filed with the respective authority/s; HRF may sue or be sued in the name of the President or the Secretary as per the Provisions laid down under Sec. 6 of the Societies Registration Act, 1860;

10.0 Bank Account :

- 10.1 The Society shall open a bank account in the name of HUMAN RIGHTS FOUNDATIONS (HRF) which shall be operated either jointly by the President Secretary, and the Treasurer or any other designated members for which proper resolutions shall have to be passed and forwarded to the Bank concerned from time to time;
- 10.2 That in the absence of the above three persons, the financial documents including cheques etc. can be signed by any other group of members of the Executive Committee nominated for the same with the approval of the President and the Secretary;
